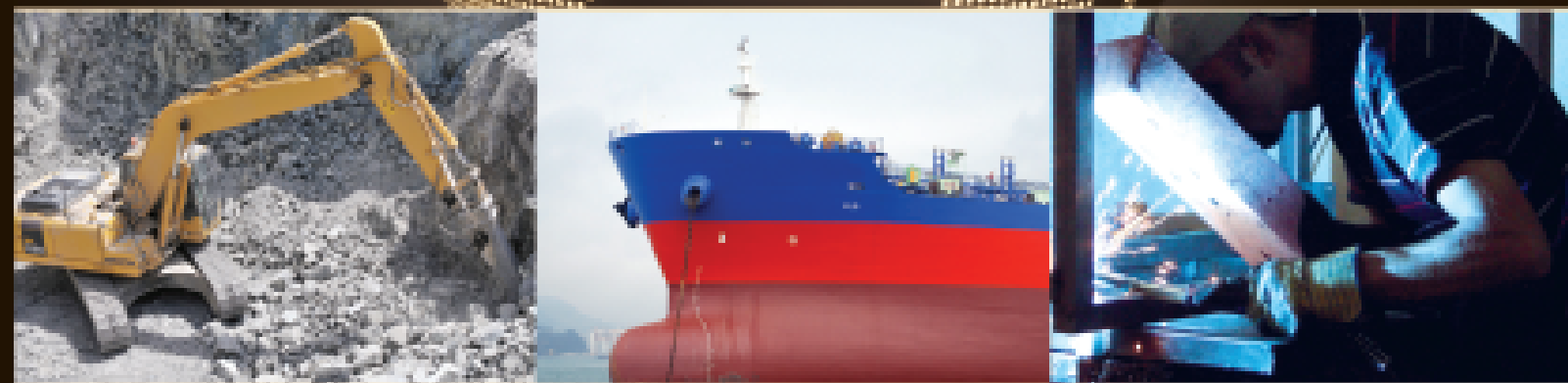

The flagship company of the group, Gulf Triangle Mining LLC, a mining company, is a leader in the Chromite ore trade in Sultanate of Oman. It is into extraction and export of Chromite ore. Since its first consignment to China in 2006, the company has been recognized as a reliable export partner. Today, it actively trades with companies from China, India and Russia to the east and South Africa, Tanzania and Mauritania in Africa.

GTM has grown to become one of the bigger companies from Oman in the mining industry. The group currently operates in 8 Chromite mining leases in Oman and holds exploration and mining permits for Laterite, Limestone, Gypsum, Copper and Manganese quarries. Another advantage enjoyed by the company is that all of these lie within a radius of 100 kms from the capital city, Muscat.

The key to Gulf Triangle's success is the planned, integrated approach to the business process across activities like mineral extracting, sorting and transporting by trucks or containers to the port. Be it in the extraction of ore at the mines or the value adding process at the mineral sorting process or transportation by trucks on the roads, each activity is efficiently carried out with regular deployment, allocation and maintenance of machinery and equipment. The quality control standards maintained at each step of the process ensure a streamlined work flow.

The company has its own mining leases in Sultanate of Oman, Sudan and Saudi Arabia. Since its inception, GTM has continuously updated itself with the latest development in technology to become a fully integrated mining company.

The present Chromite ore exports of the group are over 0.2 million tonnes per annum which can be augmented to meet additional demand. The company has been the recipient of awards of excellence in exports from Port Services Corporation SAOG for the last three years.





## Work Processes

The ongoing operations are managed by the Omani management, supplemented by expatriate specialist and specialist contracting company. Gulf Triangle Mining Company employs the open pit method in all mechanized mining operations. Benches are designed across and along the strike of the ore body for better quality control. Eco-friendly ripper and dozer and conventional drilling and blasting are preferred for the removal of over burden/waste rock. The ore is exposed after removing the waste capping. The run-of-the-mine ore is loaded into fleet of trucks by excavators and then transported to stock yard for sizing and quality upgrading.

All mining pits are designed considering factors that influence pit stability and feasibility. It includes an assessment of the rock mass, weathering and strength of the various lithologies at the mine site as well as the structural characteristics of discontinuities. The design of the ultimate slope angle, dimensions of benches are influenced by the combination of the rock mass strength, weathering, influence of discontinuities and presence and volume of water.

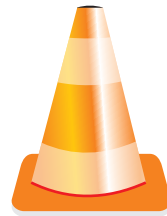
## Stockpiles and Quality control

The surplus ore stockpiles ensure continuous ore supply. The open pits are well planned with service roads that connect the mining pits keeping the activities away from urban areas and the highways. The mined ore is stockpiled in different areas according to mineralization clearly specifying their definite grade before they are hauled to Port; this is controlled and closely monitored under our grade control policy.



## Work Team

A Team of trained employees run the mines on a 12 hr shift system. The in-house training department helps develop, train and supervise operators to enhance their operating skills as per the mine working standards and requirement. The members of local community are encouraged for employment and development.

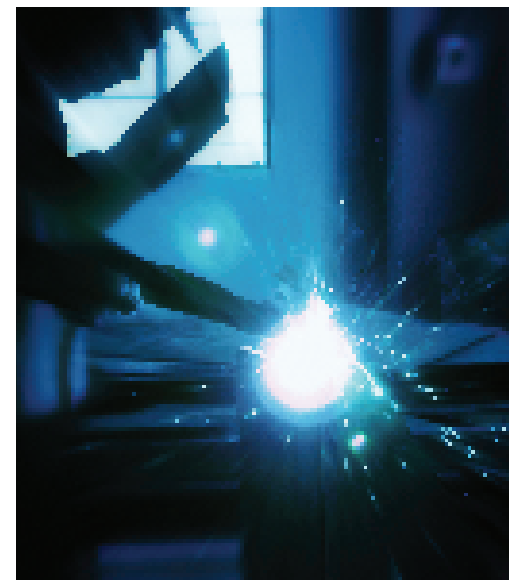
